**Illinois Residency Verification Form**

You may be eligible for an ISAC MAP grant. The college is required to verify Illinois residency before an award can be made. MAP grants are tuition scholarships.

**Independent (Acceptable Residency Documentation--only one is required):**

In order to qualify for a MAP grant as a independent student for the 2009-2010 award year, ISAC rules require that you prove, with the documentation below, that you are an Illinois resident and have lived in Illinois since August 15, 2008. To be considered an Illinois resident, Illinois must be your true, fixed, and permanent home. **The college is required to request documentation from you to verify that you meet this ISAC eligibility criteria.**

- **Signed and dated** copy of 2008 Illinois state tax return.
- **Signed and dated** copy of 2007 and 2008 federal tax returns showing an Illinois address.
- A copy of 1099-Misc. Income for 2008.
- Statement of benefits history from the Illinois Department of Public Aid or Social Security Administration showing that you received benefits from 8-1-08 to 8-31-09 or to current date.
- An Illinois high school transcript with dates of attendance from 08-08 to 05-09.
- Form DD214 or other military separation documentation showing your Illinois residency.
- A copy of your Illinois driver's license **issued prior to 8-15-08.**
- A state of Illinois identification card **issued prior to 8-15-08.**
- A copy of your Illinois auto registration card (in your name) **issued prior to 8-15-08.**
- Copies of the utility bills, rent receipts, or residential lease in your name showing that you lived at an Illinois address from 8-1-08 to 8-31-09 or to current date for **each** month.

**Dependent (Acceptable Residency Documentation--only one is required):**

In order to qualify for a MAP grant as a dependent student for the 2009-2010 award year, ISAC rules require that the parent that completed the FAFSA be an Illinois resident. Illinois must be your parent's true, fixed, and permanent home to be considered a resident. **The college is required to request documentation from you to verify that you meet this ISAC eligibility criteria. You must document that your parent was an Illinois resident on the date you applied for financial aid.**

- A signed and dated copy of your parent's 2008 Illinois state or federal tax return that shows an Illinois address.
- A copy of 1099-Misc. Income for 2008.
- A state of Illinois identification card issued to your parent **prior to 8-15-08.**
- A copy of your parent's Illinois auto registration card **issued prior to 8-15-08.**
- A copy of your parent's Illinois driver's license **issued prior to 8-15-08.**
- Copies of utility bills, rent receipts, or residential leases verifying an Illinois address for your parent **issued prior to 8-15-08 (6 months).**
- Statement of benefits history from the Illinois Department of Public Aid or Social Security Administration showing that your parent received benefits for each month during the year of 2008.
- Form DD214 or other military separation documentation showing your parent's Illinois residency.

**All documentation must be typed on agency letterhead.  
Handwritten documents are not acceptable.**

**Note:** If you do not have one of the above forms of documentation, you may appeal directly to the ISAC.  
**John A. Logan College cannot waive this requirement.**
