

## STANDARD ONE-YEAR CONTRACTS

The form contract for employees with one-year contracts and a list of the persons and salaries with one-years contracts is set out below:

### AGREEMENT

Agreement made between Board of Trustees of Community College District No. 530, counties of Williamson, Jackson, Franklin, Randolph and Perry and State of Illinois, hereinafter called "Board," and (employee name), professional employee of John A. Logan College, hereinafter called (employee name).

Witnesseth: That in consideration of the mutual promises and agreements herein contained, the Board hires and employs (employee name), and agrees to work for and in the service of the Board, under the following terms:

(Employee name) is engaged to work in the capacity of a professional staff employee for a term of one year, commencing on the first day of July, 2016, and ending on the thirtieth day of June, 2017, provided that this agreement is subject to the Board of Trustees' policies as currently adopted or which may hereafter be adopted or amended authorizing the College to terminate programs and to furlough or layoff employees during the term of the employee's contract upon the declaration by the Board of Trustees of a financial exigency.

(Employee name) agrees as follows:

To perform the duties and assume the responsibilities outlined in Administrative Procedure and Board Policy. These duties and responsibilities may be revised by the Board from time to time.

The Board agrees as follows:

To pay (employee name) for his/her services to be rendered hereunder the annual sum of dollars (\$ ) per year, with the right of the Board to increase the compensation over the compensation herein stated, from time to time, as may be provided by the Board, without

Invalidating any other provisions of this contract. It is mutually understood and agreed that the professional employee named herein is subject to any and all policies of the Board.

Failure on the part of the professional employee to accept this employment contract by affixing his/her signature and delivering or mailing to the Office of the Board, Illinois Community College District No. 530, Carterville, Illinois, within thirty (30) days of the mailing date on this contract shall be construed as a rejection of this appointment by the employee.

This agreement constitutes and expresses the whole agreement of the parties.
