1) John A. Logan College (“the College”) signed and returned to the Department of Education the Certification and Agreement on April 16, 2020. When receiving funds, the College has used 50 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(A)-(D) and 100 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(E)-(F) to provide Emergency Financial Aid Grants to Students.

2) The College was awarded the following amount of funds from the Department of Education pursuant to the College’s Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) programs:

6) The College requested students to submit an application in order to receive an Emergency Financial Aid Grant under the CRRSAA and ARP (a)(1) programs and prioritized students with exceptional need. The methods used by the College to determine which students received an Emergency Financial Aid Grant and how much they would receive are as follows:

- Students must have been enrolled for 3 credit hours or more in a certificate or degree-seeking program at the time of application.
- Applications were removed if they disagreed with the certifications that the expenses were related to the coronavirus.
- Award amounts were as follows:

7) Eligible students for the spring 2021 semester received email notification on March 18, 2021 from the Provost’s office, requesting them to complete an application. The application allowed eligible students to accept emergency funding to be used towards the cost of attendance, food, housing, course materials, technology, health care, childcare or similar expenses associated with the COVID-19 pandemic.
