#### **Required Documentation:**

- Statement of all employers your parent worked for
- in 2023 and dates of employment.
  Copy of your parents' 2023 federal IRS 1040 tax transcript.
- 3. Copy of both parents' 2023 W-2 form(s).
- Your parent received unemployment compensation, or **D** C. some other taxed or untaxed income or benefit for at least ten (10) weeks in 2022, but has completely lost that income or benefit.

#### **Required Documentation:**

- 1. Statement of termination from the source of income. Include dates your parent received the income. NOTE: Income and benefits include: Social Security, court-ordered child support, retirement or disability benefits; and
- 2. A statement from the source of the income indicating the dates, and the amount your parent received in 2023.
- 3. A copy of your parents' 2023 Federal IRS Tax Return transcript.

## **Required Documentation:**

- 1. Copy of your parents' 2023 federal IRS 1040 tax transcript;
- Statement from source of one-time income indicating amount; and
