XI. CONSENT AGENDA (Voice Vote)

A. Repayment of Inter-Fund Loans

At the June 26, 2007 Board of Trustees' meeting, it was approved that the following inter-fund loans would be made in accordance with the Illinois Public Community College Act, Illinois Compiled Statutes, Chapter 110, Act 805/3-34 effective June 30, 2007. We are now requesting Board approval to pay back these loans during the 2007-2008 budget year as follows:

- Inter-fund loan from the Working Cash Fund to the Trust and Agency Fund in the amount of \$50,000;
- Inter-fund loan from the Working Cash Fund to the Liability, Protection and Settlement Fund in the amount of \$200,000.

Recommendation: That the Board of Trustees approve inter-fund loan repayments from the Trust and Agency Fund in the amount of \$50,000; and from the Liability, Protection and Settlement Fund in the amount of \$200,000 to the Working Cash Fund.

B. Microsoft Software Licensing (Attachment III)

John A. Logan College uses computers that run Microsoft Windows operating systems and Office software. The College purchases Microsoft Campus Agreement annual licensing that allows all College computers to use Windows and Office Software products. The agreement also allows College employees to use it on their own personal computers at home for work related purposes. This year, Visio has been added to the suite of software packages included with our agreement.

This is an increase of \$7,450.73 over last year's fee which was \$28,446.30. Information Systems has gathered three price quotes as follows:

Recommendation: That the Board of Trustees approve the purchase of the Microsoft Campus Agreement annual licensing from Educational Resources for an amount of \$35,897.03, and that the administration be authorized to renew this agreement with Educational Resources.

C. Pell Grant Book Vouchers for Spring 2008 Semester

Each semester, the College issues vouchers to students who are eligible to receive federal Pell Grant funds so that those students may obtain their textbooks at the beginning of the semester before they actually receive their federal scholarships. This is a College initiative that has worked out well the past seventeen years and has enhanced instruction and learning for many students. 710 Bookstore issues textbooks to the students based on the vouchers that are approved by the Financial Aid Office, and the College must reimburse the bookstore when the federal aid is received by the College for the students. That federal aid has now been received.

A total of 776 students availed themselves of Pell Grant book vouchers for spring semester 2008 for a total amount of \$260,868.13.

Recommendation: That the Board of Trustees approve payment to 710 Bookstore in the amount of \$260,868.13 for textbooks issued to Pell Grant students, and that the administration be authorized to make this payment.

D. Approval of New Associate Degree in Fire Science

Approval is requested for a new Associate in Applied Science Degree in Fire Science to be offered at John A. Logan College.

Regional fire chiefs have expressed the need for an in-district fire science degree program because of the high cost associated with sending firefighters to training centers and the availability of in-district training resources available at the Williamson County Fire Protection District and Southern Illinois University Carbondale. Within southern Illinois, volunteer firefighter positions are ample, and paid employment opportunities exist at fire suppression companies, alarm companies, municipal, state, and federal fire organizations, and the U. S. Forest Service.

This associate degree is designed to provide college credit for firefighter training and in-district training opportunities for firefighters. This degree will qualify under the Capstone Program at Southern Illinois University for A.A.S. Graduates wanting to complete a Bachelor of Arts degree in fire science.

For this degree, all general education classes have already been approved by ICCB and articulate to Southern Illinois University Carbondale. Professional and technical courses have been developed specifically for this curriculum that parallel skill requirements outlined by the Illinois State Fire Marshal's Office. Because all technical and professional courses have been developed to be taught at off-campus locations, this program does not require additional space or training facilities.

The effective date of this program is fall semester 2008.

Recommendation: That the Board of Trustees approve a new Associate in Applied Science Degree in Fire Science to be offered at John A. Logan College effective fall semester 2008.

E. Approval of New Certificate Programs for Fire Officer

Approval is requested for new Certificate - Fire Officer and Firefighter programs at John A. Logan College.

The **Certificate - Fire Officer I** is a 15 credit hour program. After the completion of this certificate, firefighters will qualify for the Illinois State Fire Marshal's certification exam. Fire Officer I certification will allow advancement opportunities and include instructor training to provide the district with qualified firefighter trainers.

After completion of this certificate, firefighters will only need 33 credit hours to complete their A.A.S. degree. These certificate programs were developed to meet state mandated training and provide stepping stones toward the A.A.S. degree in Fire Science.

The **Certificate - Firefighter II** is an 11 credit hour program. After completion of this certificate, firefighters will qualify for the Illinois State Fire Marshal's certification exam. Firefighter II certification will allow advancement opportunities and is a pre-requisite for Firefighter III training.

The **Certificate - Firefighter III** is an 11 credit hour program. After completion of this certificate, firefighters will qualify for the Illinois State Fire Marshal's certification exam. Firefighter III certification will allow advancement opportunities and is a pre-requisite for Fire Officer I Training.

The effective date for these certificate programs is fall semester 2008.

Recommendation: That the Board of Trustees approve new certificate programs – Certificate-Fire Officer I; Certificate-Firefighter II; and Certificate-Firefighter III effective fall semester of 2008.

F. Renewal of Community Partner Agreement with Southern Business Journal (Attachment IV)

It is desirable to renew the College's Community Partner Agreement with the *Southern Business Journal* for a two year period of May 1, 2008 through April 30, 2010. This has proven to be a very positive relationship for the College, resulting in a great deal of excellent publicity both in print and through exposure of the College's facilities – especially through the Community Leaders' Breakfasts held on our campus. The value of the College's investment is \$18,000 per year (total of \$36,000). However the *Southern Business Journal* gives the College a \$8,000 trade for use of facilities each year, leaving a cash balance owed of \$10,000 each year of the two-year period. This amount is billed monthly in \$833.33 increments. This represents no increase from previous agreements. A copy of the agreement is included as Attachment IV.

Recommendation: That the Board of Trustees approve renewal of the College's Community Partner Agreement with the *Southern Business Journal* for the two-year period of May 1, 2008 through April 30, 2010, for an total cash amount owed of \$10,000 per year (\$20,000), and that the administration be authorized to pay this amount in monthly increments of \$833.33.

Recommendation: That the Board of Trustees consider revisions to Board Policy 5220C – Non-Teaching Professional Salary Schedule and 5220D – Vice Presidents as contained in Attachment V, provide input, and take action on the final revised policies at the May 27, 2008 Board meeting.
