

2026-2027 Verification Worksheet

Your 2026-2027 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we must verify the information you and your parents reported on your FAFSA is correct. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit information requested to the John A. Logan College Financial Aid Office. If there are differences, your FAFSA information may need to be corrected. If you have questions about verification, contact the Financial Aid Office at John A. Logan College as soon as possible so that your financial aid will not be delayed.

B. Dependent Student’s Family Information-Family Size includes:

- The student.
- The student’s parents, (or stepparent if applicable) even if the student is not living with them. Exclude a parent who has died or is not living in the household because of separation or divorce. Include a parent who is on active duty in the U.S. Armed Forces apart from the family.
- The student’s siblings if all the following are true:
 - They live with the student’s parents (or live apart because of college enrollment);
 - They receive more than half of their support from the student’s parents; and
 - They will continue to receive more than half their support from the student’s parents during the award year.
- Other persons if the following are true:
 - They live with the student’s parents;
 - They receive more than half of their support from the student’s parents; and
 - They will continue to receive more than half their support from the student’s parents during the award year.

The provided criteria for “dependent children” or “other persons” mirror the requirement that family size align with those the parent could claim as a dependent on a U.S. tax return if the parent were to file a U.S tax return at the time of completing the 2026-2027 FAFSA. As a result, the parent should not include any unborn children in the family size. If more space is needed, provide a separate page with the student’s name and ID number at the top.

C. Dependent Student's Income Information to Be Verified

Instructions: Complete this section if the student filed or will file a 2024 IRS income tax return. As part of federal student aid eligibility, students are required to consent and approve sharing and importing income and tax information from the IRS to the FAFSA form, even if the attempt to obtain or use such data is ineffective.
